Minutes of meeting held $\mathbf{1 0}^{\text {th }}$ October 2023

### 5.1 To receive apologies for absence: None.

### 5.2 To consider requests for dispensation and pecuniary \& other interests on items on the agenda: None.

5.3 To receive petitions, comments and questions from the public: None.
5.4 To approve minutes Council Meeting 12 $^{\text {th }}$ September: Resolved: The minutes of the Council Meeting of 12 September were approved and signed by the Chairman as a correct record.
5.5 To receive reports on meetings \& events attended by Councillors: Cllr Dix assisted the Church with its open day event.
5.6 To receive correspondence: The Council received: A thank you letter from the church for help by Cllr Dix with its open day. A complaint from HFHS that the wifi in the main hall is not good enough for Zoom meetings. A resident informed the Council of exposed nails on the gate post of the hall playground; the post has been replaced. A resident complained that the landowner does not reinstate the Right of Way across the ploughed field to Cave Wood; the landowner and Rights of Way Officer have been informed. Permission was sought from the Mayor of Broxbourne's office for permission to wear their chain of office at a charity event being held at the hall. A letter was received from a resident of details of a near miss on the Chequers bend and asked if yellow lines could be installed (see item 5.10 b (ii)). Cllrs were informed of a HCC survey about developing relationships between HCC and Local Councils.

5.8 Hall (Cllr Corke \& Pinney) \& Grounds: (Cl/r Dix)
a) To consider quote for manifold covers: Deferred.
b) To consider work to Family Centre heating: The cost of repairing the heating in the Family Centre is prohibitive at present considering how the rooms are infrequently used. It was agreed to provide a small heater as an interim solution.
